## Call for entries

### **Writing Photography. DGPh-Preis für innovative Publizistik / DGPh Award for Innovative Publication**

#### **Blogs, columns, online articles – innovative publications based on or featuring photography shape the way we regard the medium**

Every other year, the German Photography Society (DGPh), in collaboration with the Deutsche Börse Photography Foundation, awards a prize for innovative publication in recognition of journalistic, essayistic or other publications.

Photography is no longer debated and reflected upon exclusively in scientific publications. Rather, we have seen the development of a digital culture of discussion, dedicated to an innovative look at the entirety of facets represented through the medium. This prize directs its particular focus on smaller publications such as exemplarily selected blog posts, columns and reviews, online publications and formats which creatively combine texts and photographic material.

We invite submissions of published content, either digital or analogue, from the last two years. Please choose individual contributions or a series of related contributions with reference to the publication context, for example from blogs or a particular website section. An international jury will determine the recipient of the €1,000 prize. The award ceremony will be held as part of a public event, jointly organised by the DGPh and the Deutsche Börse Photography Foundation in 2023.
